

# Minister's Annual Report

May 2021

I think it is appropriate to begin my Annual Report by saying this has been an extremely challenging year, not just for the Fellowship but also for the nation and the world. When the COVID virus reached Montana in March of 2020 we knew that many challenges would have to be faced in the coming months. At that time however, most of us didn't imagine that 15 months later we would still be holding our services, committee meetings and social groups online. We had no way of knowing the sacrifices that would need to be made throughout the course of the COVID pandemic. The COVID virus was more than enough challenge by itself, but it wasn't the only challenge we faced. In the latter part of 2020 the country held a Presidential election that may go down in history as the most contested electoral college, our nation's Capital Building was attacked and overrun by a group of citizens intent of overturning the will of those who voted by denying the elected President from taking office. In addition, the nation has been in a time of reckoning regarding racial injustice as people of color have suffered and died at the hands of police and have been impacted much more by the COVID virus than people who identify as "white." This has been an extraordinary year.

While facing the unexpected and daunting challenges of the past year the members and friends of UUFB found ways to continue most of the important aspects and functions of the Fellowship. As you review the committee reports in this document you will get a good sense of what we were able to accomplish this year in spite of the difficult circumstances we were dealing with. Here are some examples of what we managed to do. Even though we haven't been able to use our building for inperson meetings during the past year we held two Annual Meetings online, one in May and one in January. We conducted our annual pledge drive, again online. And while we didn't meet the goal that had been set, the amount pledged was quite impressive in light of the pandemic and the state of the economy. We held Sunday services, after-service social times and children's Religious Exploration classes online. Because most of our services were online, people from all over the country have been able to attend, including both former members and friends as well as people who have never attended one of our in-person services. We shared two services with the Billings UU Fellowship. We had 11 guest ministers, most of whom were UU ministers, from various parts of the country share their wisdom and inspiration with us. We held several outdoor gatherings including a service at Bozeman Pond led by a gifted musician friend of the Fellowship.

As I said previously, this has been an incredibly challenging year. Yet in spite of the challenges, the members and friends of UUFB have provided support to one another and found ways to persevere. This year has demonstrated to me the commitment, strength and power that is present in this Fellowship. I am grateful to have the opportunity to journey with you. Thank you for offering me the opportunity to learn with and from you.

# Board of Directors Report

#### Annual Report 2020-2021

#### **UUFB Board of Directors**

In early July of 2020, the Board met in our summer retreat to set goals for the coming year. Those goals were published in the November 2020 newsletter, and they then informed the Board's agenda for the year. Probably because it was so obvious and so little could be predicted in July, dealing with COVID-19 was not explicitly included as a separate goal. So our report includes both progress on the goals we did set as well as a including many actions the Board took as we moved into and through a very challenging year. The past "Covid-19" year has been one of intense and often jarring challenges for the Fellowship and the Board, but the transition into a new year begins to suggest the possibility of near-term relief and amelioration of constraints.

The first—and easiest—decision we made was to continue streaming Sunday services permanently, and equipment has been purchased to do so. It's looking somewhat more likely that we may be able to hold services in our building at some point in 2021. (See the attached "Protocols" for beginning to gather in person.) We are also looking at the budget implications for holding two services, should it be necessary to meet the social distancing guidelines likely to be with us for several months even as the vaccines work.

### **Goal: Maintain Organizational Stability**

The Board committed itself to providing effective and efficient oversight and management to ensure the financial health and safeguard the organizational effectiveness of UUFB via sound policies, procedures, and practices.

We developed a position description for a (volunteer) position as Building and Grounds Coordinator and appointed Tonya Stevens to fill it. She will work with Mike Clark, Carolyn Boyd, and others to make sure policies are followed and everything stays in good working order.

Other actions:

- Program Council met on Zoom six times.
- We approved modest year-end bonuses for all staff in recognition of their hard work adapting our services and programs for online delivery and approved 2% cost-of-living raises for them.
- We extended the responsibility of our CRE, Beth Witte, to include Youth Group. Beth will be responsible for leadership of the program, and we added hours to Christine Wilcox's time for more staff involvement with our youth.

- With regret, we accepted Laurel Yost's resignation as music coordinator and this spring appointed a Music Task Force to review staff support for our music program.
- We continued the appointment of Erin Henke to perform hymns for streamed services.
- We maintained our financial stability in unsettled times, without seeking PPP loans or other outside resources. Through the new capability for online donations, we kept up impressive Second and Fifth Sunday contributions to organizations sharing our values, as described elsewhere in this report.
- Though the fall Stewardship campaign fell somewhat short of the goal, the average pledge amount increased significantly, and pledge fulfillment for the previous year was an impressive 98%.
- We received a generous anonymous donation to our capital campaign, which has, of course, ended. The donor agreed that the gift could be transferred to Capital Improvement Special Fund. We finally closed the separate construction checking account and moved remaining funds from the capital campaign to the Capital Improvement Special Fund.
- We amended the bylaws to specifically allow voting by mail and on-line.
- We approved new charges for the Finance Committee and Social Justice Action Committee, clarifying roles and support for their activities.

### Goal: Increase Community Growth & Visibility

The Board committed to increasing community growth and the visibility of the UUFB Mission by connecting with millennials, and diversifying membership by means of an improved social media presence, a refined self-narrative, and collaboration with outside community groups.

- Valley Peters created a video for us to participate in Virtual Catapalooza at MSU.
- Some of our neighbors responded to our invitation and participated in our New Year's Eve "Dumpster Fire" in the parking lot.
- We posted more frequently on Facebook in the past year and have developed a calendar for posting around special events or holidays in the future.
- We were the only religious community to advertise in the Earth Day supplement in the *Bozeman Daily Chronicle*.
- We participated with others in the Gallatin Valley Interfaith Alliance to assure full funding for Fork and Spoon in 2021. Each of twelve congregations pledged \$1000; UUFB raised over \$5000, thanks to a matching gift from an anonymous donor. We are also partnering with GVIA to raise funds in May supporting the Tiny House project.
- We entered into a covenantal partnership with Montana Interfaith Power and Light (see <u>www.montanaipl.org</u>) committing UUFB to address climate change with other religious groups in the state and adding support for Rev. Duffy's role as chair of MT-IPL.
- We contributed nearly \$1300 in relief funds for the Bridger Foothills Fire on Labor Day weekend.

### Goal: Support, Caring and Connection

The Board commits to supporting the spiritual growth of UUFB congregants as a group and as individuals through connection, engagement, and care.

- Our year-round focus on adapting to the pandemic meant that significant Board time—at almost every meeting—was devoted to making decisions to support and protect our members.
- After many months of planning (and years of intending) we now have **assistive hearing devices** in the sanctuary! There are two options: one that works through a smart phone and another that uses a separate receiver.

- Although we couldn't hold large scale social events, we held several "pop-up" social activities like tailgating in the fall and hiking in the spring.
- A "Caring Cluster" of 15 20 UU's reached out a few times during the year to be sure we were all doing well through times of distancing; they kept in regular contact with those requesting it.

### Goal: Anti-Racism/Social Justice

The Board committed to strengthen UUFB's capacity to support BIPOC (Black, Indigenous, People of Color) social justice efforts, with emphasis on anti-racism efforts.

- Several Fellowship members participated in rallies and marches in May and June of 2020 in response to the killing of George Floyd and other Black men and women.
- Barbara Tylka and Kitty Donich of our Social Justice Action Committee prepared a clear and powerful letter about racial justice to the editor of the *Bozeman Daily Chronicle*, which the Board forwarded in the name of the Fellowship.
- On two Sundays in February and one in March there was a Zoom book group discussion on the UUA common read for 2020, *An Indigenous People's History of the United States*. (A similar series of discussions was held in February of 2020, just before COVID hit, with sufficient interest for a second group.)

#### Board Development: Serving with Grace

The Board spent a few minutes once each month to discuss a chapter of the book *Serving with Grace: Lay Leadership as a Spiritual Practice* by Erik Walker Wikstrom. He suggests that we not think of ourselves as "consumers" of the Fellowship but as shareholders or investors. When we get involved with the actual work of the Fellowship, we each become responsible for something larger than our individual selves. It also provides opportunities to learn something about oneself. As we begin to come back together after more than a year of social distance and even isolation, involvement in the life of the Fellowship can be a good spiritual practice for all of us.

#### **Recommendations for next year**

- Increase capacity to fill committee and leadership positions through recruitment events like a Committee Fair.
- Increase Rev. Duffy's appointment to full time (currently 80%).
- Explore options for Rev. Duffy to take a sabbatical.
- Increase Beth Witte's time as Religious Education Coordinator.
- Develop an Emergency Plan for the Fellowship.

## **Protocols for Resuming In-Person Sunday Services**

Unitarian Universalist Fellowship of Bozeman

2021

The Board is fully committed to the safety and health of the fellowship and wider community and also feels that a return to in-person Sunday services beginning June of 2021 is both feasible and desirable. As we plan for re-opening during a pandemic, we are in uncharted territory, and there are likely to be mistakes and recalculations. We will strive to be patient, to adapt and adjust to changing circumstances, and to learn from our mistakes as we proceed with a safe re-opening of Sunday services. Except for the fact that we will continue to live stream services on Sunday morning, the rest of these conditions may be considered temporary.

### **General Conditions**

- This action meets or exceeds COVID19 safety recommendations issued by the CDC and Gallatin County Health Department for the size of gatherings at the time of re-opening.
- Each service will be simultaneously streamed on the internet for Fellowship members who are unable or prefer not to attend in person.
- Seating during the service will allow for six-foot distancing (or 5½" in a few specific cases) between household groups; maintaining 6' distances will be important before and after the service as well.
- Distanced seating will be provided in both the Sanctuary and Social Hall, with a video monitor in the Social Hall to show the live stream.
- Windows and doors will remain open throughout the service for maximum ventilation.
- The minister, lay leaders, and all speakers involved in the Sunday service will be fully vaccinated.
- Members will be strongly encouraged to become fully vaccinated before attending Sunday services in-person; vaccination will not be required but we will be collecting data on how many of our folks are vaccinated.
- The service will include music but not singing, to prevent the unwitting spread of the virus.
- There will be no social time or coffee hour held in the building after the service.
- If attendance overwhelms available seating, a second service on Sunday mornings may be considered.
- Erin Henke will continue to provide musical services.
- Safety protocols for bathroom use will be clearly posted and announced at each service.

#### Zoom

• Zoom for Sunday morning services will be suspended when we are streaming from the sanctuary.

### **Entering the Building**

- In-person attendees will use hand sanitizer upon entry to the building.
- Properly worn masks (covering nose and mouth) will be required; a supply will be available for those who need them.
- Gloves will also be available for those who want them.
- A reservation system will be created for accommodating in-person attendance on Sundays.
- There will be a list of those who have reserved so greeters can check off as people arrive.
- Regulars without reservations and visitors will need to wait until capacity is known.
- Nametags will not be used, at least initially.

- A few printed Orders of Service will be available for those who want one.
- Hearing assist devices will be available (cell phone and/or RF receivers).
- Hymnals will be available at the entry for those who want them, cleaned weekly.
- Offering plates (bowls) will be strategically placed for donations instead of being passed, and envelopes will be available at the foyer table as usual. Two members (at least one from the Board) will count the offering after the service.

#### For Children

- The initial plan is the LRE Committee recommendation to hold a single RE class outdoors, concurrent with the Sunday service, with Beth and Christine leading.
- Children will go directly to RE rather than starting in the Sanctuary.
- Children in diapers will not participate in RE.
- There will be a reservation sign-up system for RE as well as the Sunday service.
- Kids will stay outdoors, under a canopy if weather requires; if they need a bathroom, they can come in the *front* door and use one of those bathrooms. An adult will need to monitor and wipe it down afterwards.
- Babies may sit on parents' laps in the Sanctuary.
- At present we will not offer Nursery service. The Nursery is available as a cry space. (A stream of the service *may* be available there.)
- Toddlers and other children in diapers are welcome, with parents exercising constraint to respect social distancing.

# Livestreaming Task Force

The Livestreaming Task Force was created in 2021 to prepare for the restart of in-person Sunday services while continuing livestreaming on Facebook or other platforms. The team developed a plan to purchase and install new equipment, and is currently implementing the plan. Two cameras are being installed in the sanctuary, to be controlled by a video switcher and a monitor located in the administrative office. To facilitate the control station, the office has been rearranged with updated furniture, giving the office administrator a more useful workspace.

Seating for services is being added in the Social Hall, to spread out attendees and keep social distancing; a large TV monitor on a portable cart and speakers will be located in the Social Hall.

#### **Recommendations for Next Program Year**

The Task Force concluded that four to six UUFB congregants should be trained as rotating operators. Upon completion of training, volunteers must be willing to commit to one year of volunteer service, consisting of 2-3 hours per Sunday for one Sunday in a given month.

### Mission

This committee is responsible for general building and grounds upkeep, repairs, and additions.

## Activities/Accomplishments -

We took advantage of the building not being used to make big messes, then clean them up:

- CLEANING: Carolyn Boyd arranged for an entire-building carpet cleaning last June. She will engage a new cleaning service to start once the building is open for the congregation.
- MOWING: A new lawn service will be employed; our (college sophomore) mower moved away. There are plans for a compost top-dressing for UUFB property in May 2021.
- SHED UPDATE: As head of our shed dismantling project, Carolyn instigated a thorough examination of the boxes that were stored in the shed. Peg Wherry, Susan Backer, Bruce DePriester, and Christy Huddleston reviewed dusty archives and preserved the most important financial and historical records. Those records plus excess building materials were moved up to the balcony above the Social Hall or locked file cabinets. No-longer-used tools were given away.
- CABINETS and SHELVES: Barb Turner-Lantz continues to install new cabinetry and shelving in the large RE classroom and will soon add the last tall cabinet to the Nursery room hallway. Shelving was added to the portion of the office that the RE Coordinator will use.
- LIVESTREAM TASK FORCE. Building & Grounds collaborated with the task force on a plan for a new audio/visual setup that includes cameras in the back of the sanctuary to film and broadcast our services. A large TV monitor will be installed for viewing the service in the Social Hall. An A/V desk with control box and monitor is being installed in the office to be used by a VJ during Sunday Services. Our new set-up will allow for TV/computer monitors of the service in the Nursery Room and in the Large RE classroom. Rearrangement in the office resulted in us purchasing a new, more useful desk for the Office Administrator.
- HEARING ASSISTANCE: Mike Clark installed a hearing assist system to the sound board. Devices and headphones are now available for anyone with hearing impairment to better enjoy services.
- LIGHTING: New lightbulbs installed by Mike Clark in the sanctuary will brighten our dim corners.
- LANDSCAPING: Joy LaClaire and Barbara Tylka have teamed up as an ad hoc landscaping team to clean up the gardens surrounding the building. They will soon be putting plants in the planters. Joy continues to monitor and water our indoor plants.

### **Recommendations for Next Program Year**

1. Form 3 new groups: Landscaping group, Parking Issues Task Force, Snow Shoveling team.

- 2. Add Interior Spring Cleaning and Fellowship Grounds Workdays to May calendar.
- 3. Rearrange foyer to accommodate growing UUFB population.

- 4. Arranges for meals and/or transportation as necessary
- 5. Functions as the clearinghouse of community assistance resources.
- 6. May coordinate support groups if needed.
- 7. Responds to any other requests for help on an ad hoc basis.

Due to COVID and our congregation not being able to meet in person, the Caring Committee has had to do more phone outreach to members and friends that may be struggling for whatever reason, since we may not see them at the virtual social time after church each week. We have continued to carry out our mission of individual outreach as needed. We also made extra efforts during Christmas, Valentine's Day and Easter to reach out to approximately 20-25 members who may be more isolated than most to help them feel connected and know that we remember them. We are grateful to the RE Program and Youth Group for coordinating these holiday efforts with us.

#### **Recommendations for Next Program Year**

The Caring Committee addresses needs as they come up and we don't expect to change what we're doing in the coming year, though of course we'd love to add new members to the committee!

The Caring Cluster is not a regular committee of the UUFB. It was set up at the onset of the COVID pandemic as a way to reach out to all of UUFB's members and friends to check in and see how everyone was doing in isolation and ensure that everyone had access to the resources they needed to navigate the challenges of COVID. The idea was to ask some specific questions of each member to see if they needed connected to additional resources, as well as check in regularly with anyone interested so everyone felt less isolated and more connected to the other members of UUFB.

As our congregation has nearly 250 members and friends, this was a big undertaking that we could not have done without the help and support of all the members listed above. They made the initial round of calls in the spring of 2020 and for those folks who wanted regular check-ins, they continued to make phone calls on a weekly or monthly basis. We were ready to help with things like grocery or medication pickup, with Beth Witte and Norm Eggert to coordinate volunteers, although this need did not develop. The group's activities were also supported by Rev. Duffy, dealing with particular concerns, and Christine Huddleson, providing information to do the work. The Hospitality & Membership Committee also coordinated with the Caring Cluster in this work.

As the pandemic dragged into the summer of 2020 (and we realized that it wasn't going to end anytime soon), we made a second round of calls to everyone to see if their situation had changed and make sure they still had the support they needed. Thankfully, it seemed that most people did.

As the Caring Cluster arose from an immediate need in response to the pandemic, we do not foresee it continuing into the next year.

#### **Committee's Mission**

- 1. Focus on all aspects of the congregation's ministry in light of the mission statement by working with the minister, the board and the committees.
- 2. Ask committees (and the board and the minister) to reflect on the particulars of their ministry, assess their ministry and plan for the future, all in light of the mission statement.
- 3. Receive concerns brought to or recognized by the committee, reflect on those concerns and develop proposals to relevant bodies who may best address them.

Conduct periodic ministerial reviews and congregation assessments.

#### **Activities/Accomplishments**

- Our primary goal this year has been to conduct the Fellowship Assessment. We are currently in the process of interviewing a broad cross section of Fellowship members and friends. We ask a few open-ended questions to get the conversation started and have met via Zoom. The Committee on Ministry (CoM) plans to report to the Board and Fellowship sometime later this spring or summer. The form of this report is still being discussed.
- 2. We have had two joint CoM/Board meetings throughout the past year. The purpose of these meetings has been to foster improved communication between the CoM and Board. Our hope is that these meetings prevent problems through meeting/dialogue/building trust and right relations. The intent is for the Board and CoM to meet quarterly. The next one is scheduled for June.
  - a. The main topic of discussion for these meetings has been our Fellowship Ministry in the time of Covid.
  - b. In the last joint meeting, the CoM and Board discussed issues regarding how we safely open the Fellowship to in-person services and all that this entails.
- 3. The CoM, along with the Board, reviewed and discussed Rev. Duffy's "Best Work Portfolio".
- 4. Dave (CoM chair) has participated in the quarterly Program Council meetings and reported on the activities of the CoM.
- 5. Beth has been our liaison to the Leadership/Governance committee and has reported back to the CoM.

The CoM continues to discuss and respond to comments from the QACC (Questions, Appreciations, Comments, Concerns) box. We implemented (with much help from Christy Huddleston) a way to enter a QACC comment via the UUFB website.

#### **Recommendations for Next Program Year**

- 1. Our main goal is to finish the Fellowship Assessment and report the results to the Board and Fellowship.
- 2. The CoM will continue with the quarterly joint CoM/Board meetings with the goal of enabling the safe reopening of our Fellowship to in-person services.
- 3. The CoM will continue to respond in a timely manner to all QACC input.
- 4. The CoM chair will continue to participate in the quarterly Program Council meetings.

#### **Committee's Mission**

Assist the UUFB Board in managing the financial resources of the Fellowship and overseeing the general financial health of the congregation.

#### **Activities/Accomplishments**

- With the assistance of the Office Administrator, developed the 2021 UUFB Budget which was approved by the fellowship in January.
- Monitored the Fellowship's financial condition in 2020 to ensure revenues would meet or exceed expenses in a year of great uncertainty. Advised the Board that expense and staffing reductions were not needed.
- Worked with the Board to develop UUFB Policies.
- Conducted an Internal Financial Review of UUFB which included a review of financial procedures and processes, banking and progress since the 2017 Internal Financial Review and assessed the overall financial health of UUFB. The report will be submitted to the Board in May, 2021.
- Welcomed Sharon DePriester as a new member of the Finance Committee.

#### **Recommendations for Next Program Year**

- Continue to monitor monthly financial results to maintain UUFB's financial health.
- Work with the Board to develop and document key policies and procedures.

#### **Relevant numbers**

Working with the Investment Committee, increased UUFB's financial reserves through annual additions to the reserves and prudent investing of the reserves.

# Investment Committee

#### **Committee's Mission**

To manage investment risk and to optimize investment returns within acceptable risk parameters for the **Reserves & Special Funds**, which includes the Fellowship Development Fund, Justice and Outreach Fund, Long-term Facilities Reserve, Minister Sabbatical; and an **Endowment Fund** for the purpose of providing additional financial reserves to assure the long-range future of UUFB, to help fund financial emergencies and to fund projects that support the vision and mission of the fellowship.

#### **Activities/Accomplishments**

All accomplishments can be credited to a strong market. After a downturn in the spring of 2020 both funds showed strong performance and excellent returns during the past year. 80% of each fund continues to be in Socially Responsible Investments, screened for environmental, social and governance that invest in companies aiming to have a sustainable and societal impact in the world. 20% of each fund is Indexed directly with the S&P 500 providing a low administrative expense. The **Reserves & Special Funds** remains invested with a 60% equity and 40% fixed income allocation. The **Endowment Fund** is slightly more aggressive, invested with a 68% equity and 32% fixed income allocation.

The committee met with North Fork Financial, UUFB's contracted financial advisory firm February 24, 2021.

On March 15, 2021, the UUFB Board updated the names on the account with our advisor North Fork Financial, agreed to the Investment Committees recommended allocation for each fund and adopted the Investment Committee's Investment Policy.

#### **Recommendations for Next Program Year**

Continue with the current allocations for the funds. Also, it is our understanding that any name changes on the account will provided to North Fork Financial after any board changes.

# Relevant numbers: number of volunteers participating, number of events/activities held, individuals served, etc.—whatever is relevant to this committee

As of the end of March, the <u>Reserves & Special Funds</u> had a market value of approximately \$102,000, roughly tripling the original amount invested in August 2018 due to a combination of contributions as well as returns. The <u>Endowment Fund</u> is up 25% from its original 2018 investment value to \$6,630 as of the end of March 2021.

# Stewardship Committee

Because a volunteer to lead the Stewardship campaign was not found in time this year, the Board took on that responsibility. All Board members were involved in one way or another, with Peg Wherry, Neil Schwarzwalder, and Sally Russell especially involved in the planning.

#### **Committee's Mission**

To plan and carry out an annual campaign to communicate with members and friends about the financial needs of the Fellowship and encourage them to pledge their support to the operating budget.

#### Activities/Accomplishments

The theme of the campaign was "Meeting the Challenges," reflecting the exceptionally challenging events of 2020. Due to restrictions on in-person events, the Stewardship focus this year was a special Sunday service on November 1, which featured statements from several UUFB members: the Watson family, Barbara Tylka, Jack Fisher, Rachel Rockafellow, and Neil Schwarzwalder shared their testimony about the importance of UUFB in their lives. On other Sundays, "Stewardship Moments" were presented by Bruce DePriester, Paul McVey, Tonya Stevens, Valley Peters, Sally Russell, and Peg Wherry.

One innovation this year was a pledge drive page on our UUFB website, featuring links to the brochure and other print materials, the familiar thermometer showing progress toward our goal, and an online pledge form. This online form generated an immediate confirmation email, another enhancement.

#### **Recommendations for Next Program Year**

Those who have led the Stewardship effort for the past several years are stepping aside after long service. It is time for new leaders to step forward. This leadership role requires good organization, excellent communication skills, and a deep commitment to the well-being of the Fellowship. *It does not require "asking people for money."* Most UUFB members make pledges every year, so the Stewardship campaign exists primarily to remind people of the need, review the process, and to explain it to newcomers. Unlike other committees, this one is time limited—the work starts in the early fall and is done before Christmas. The "special Sunday" focus event should not be used again next year.

The goal for the campaign was only modestly higher than the previous year, due to the year's economic uncertainty. Both the number of pledges and the total amount pledged were smaller than the previous year but higher than in the fall of 2018; the average pledge was \$130 higher than the previous year.

#### **Committee's Mission**

Since Covid it has been difficult to stay active in our mission of welcoming visitors, members and friends. In normal times we offer a UUFB Orientation and Membership class with a Membership Ceremony for those becoming members. We recognize and help integrate new members into the life of the congregation. We keep the membership list as current and accurate as possible, continuously updating a Members and Friends Directory coordinating with the Office Administrator. We try to identify and contact attendees who drop away. This year we have met monthly by Zoom, and the committee rotates leadership responsibilities.

#### Activities/Accomplishments

When the building was closed due to Covid we coordinated with the Caring Committee to contact all members and friends to ascertain needs. Several members maintained monthly contact with those requesting it. Follow up happened again in January.

In August, with permission from the Board, we held a successful outdoor gathering on the fellowship lawn to follow up with new members. We gained valuable information from them on how well the Zoom Orientation had gone for them and their recommendations for changes. One significant suggestion was that not all feel comfortable standing up in front of the congregation for the Welcoming Ceremony. That has been re-written so there are several options. For Orientation they requested more information on committees' work, not having too many in a group, and having more than one session to go into more depth on topics. Although we asked for photos and bios of the new members, which we would have normally posted in the social hall, only one person responded after several requests.

In February and early March we held three Zoom orientation sessions, well received and attended by folks from Bozeman, Washington, and Georgia. The sessions were 1) Orientation to Unitarian Universalism by Rev. Duffy, 2) Participants own spiritual journeys, and 3) A short history of the UUFB by Susan Backer with Peg Wherry presenting information on the Board, Committees, how the fellowship runs and how to become involved.

Recent meetings have focused on how to handle greeting, nametags, handing out OOS and other related issues when we hopefully gather back in the building in early June. Much depends on plans the Board is making. Our committee has definitely voted not to be involved in coffee making and cleanup. Darla Timmons has gathered information on how other churches in Bozeman have been handling resuming services in their buildings.

#### **Recommendations for Next Program Year**

Three sessions for orientation worked very well on Zoom, and we felt that time was actually better shared in that format.

- Support emergencies in our local community
  - Bridger Foothills Fire Relief \$1,283
- Decided SJAC should concentrate our efforts on three long-term foci: racial justice, income inequality, climate justice.
- Adopted the Crow reservation as priority recipient of our support efforts to combat income inequality and food insecurity. The \$1,235 raise to support Faith, Hope and Love Ministries Inc. (Lodge Grass's food bank) initiated this priority.
- Recommended to Board that UUFB become an active member of Montana Interfaith Power and Light. The Board approved.
- Promoted viewing of Montana Interfaith Power and Light's "Kiss the Ground" for Earth Week 2021.
- Promoted viewing and set up discussion groups on UU's "Transgender Inclusion in Congregations: Welcome as a Spiritual Practice" webinar series. First of six discussions was 3/13/2021.
- Approved the placement of an Equal Rights Amendment sign in front of UUFB.
- Adopted policy on Yard Signs. Limit of one sign at a time and no more than three months per sign.
- Adopted policy of allowing 3-minutes on speakers for Sunday offerings. Max time 5-minutes.
- We worked on plans for the placement, acquisition, and installation of the flagpole. The location of the flagpole was decided by a Flagpole location taskforce, on which SJAC participated and the southeast corner of the UUFB property was chosen as the preferred location (Board approved). Unfortunately, our attempts to have a local artist design and provide the flagpole fell through officially in April 2021. SJAC is developing a new plan and budget for a commercial flagpole.
- Activity reports on Gallatin Valley Food Bank, Fork and Spoon, and Family Promise of Gallatin Valley are included below.

### **Recommendations and Plans for Next Program Year**

- 1) Continue our mission as stated above
- 2) Develop and present to the congregation our three focus areas of social, economic, and social justice, including our continued support for the Lodge Grass Food Bank.
- 3) Develop and implement new plan for flagpole.
- 4) Recruit new coordinators and/or co-coordinators for our committed projects: Family Promise, Fork & Spoon, and the Food Bank.
- 5) Set up Google Drive/Docs for storing and coordinating all past and current SJAC documents.
- 6) Coordinating efforts to support HRDC's Tiny House Village.

# Fork & Spoon Volunteer Coordination Committee

#### **Committee Members**

- Volunteers None. COVID pandemic restricted volunteering this past year

Fork & Spoon is an HRDC program that provides a dinner service restaurant Sunday through Friday from 5-7PM with a classically trained chef. It is a pay-what-you-can meal deal. The atmosphere is very much like a restaurant with a welcoming host who takes dinner orders, table service, dish busing, and full kitchen staff, allcatering to the dinner guests. The Power of We (UUFB, Pilgrim Congregational, and Temple Beth Shalom) provides volunteers once a month on the fourth Thursday. Typically, three to four UUFB volunteers join threeto four volunteers each from Pilgrim Congregational and Beth Shalom to make up the 10-11 volunteers needed for a dinner service. Volunteering is a tiring, but enjoyable service.

#### **Committee's Mission**

- 1) Coordinate UUFB's contribution of three to four volunteers to the Power of We team each month.
- 2) Lead the coordination of the Power of We's 10-11 Fork & Spoon volunteers.

#### Activities

- There have been no volunteer opportunities for dinner service since March 2020 due to the pandemic.
- The SJAC coordinator makes sure there is a full team of volunteers from the Power of We each month andreports the volunteer numbers each month to the Power of We and the HRDC Fork & Spoon coordinator.
- Monthly UUFB coordination: Service opportunities are posted each month in printed Orderof Service announcements. A sign-up sheet in posted in UUFB social hall. Typically, three to four (or more) UUFB members volunteer to serve each month.Christy is a big help, as she puts up sign-up list each month and sends list of volunteers to the coordinator. The coordinator then works/negotiates with Beth Shalom and Pilgrim to get 11 volunteers (10 required) to the dinner service the fourth Thursday of each month. The coordinator makes sure volunteers know what they should expect and what to do when volunteering.
- The coordinator provides information on F&S serving to UUFB congregation through printed and verbal announcements.

#### Accomplishments

• Raised \$5,475 through two Sunday offerings to support Fork and Spoon's take out service.

#### **Recommendations and Plans for Next Program Year**

1. Hope starting soon, the pandemic restriction will ease and the coordinators at UUFB, Pilgrim Congregational, and Beth Shalom will solicit and coordinate volunteers for the fourth Thursday every month.

- 2. Getting sufficient volunteers from UUFB each month was relatively easy prior to pandemic and hopefully this will continue to be case when F&S dinner service resumes.
- 3. Recruiting a new coordinator.

# Family Promise of Gallatin Valley

#### Mission

Family Promise of Gallatin Valley in Montana (<u>https://www.familypromisegv.org</u>) is a non-profit organization working with diverse faith organizations helping Gallatin Valley's homeless families with children by providing temporary housing. UUFB partners with St. James Episcopal Church at their Rectory by providing meals and serving as companions evenings and overnight for 5 weeks of the year.

#### **Pandemic Effects**

As coronavirus danger increased in June of 2020, Family Promise (FP) stopped asking for church volunteers as hosts but continued to have them supply evening meals. St. James Episcopal Church volunteered their Rectory building to remain the home for homeless families until pandemic end, so FP discontinued moving families from church to church. By August of 2020, requests for FP housing had tripled due to job loss during the pandemic. The FP Day Center was converted to enable housing 2-3 families. FP staff have moved to temporary office space.

#### Hope For The Future

Groundbreaking for a new Family Promise Day Center and Early Childhood Learning Center (<u>https://www.familypromisegv.org/capitalcampaign</u>) took place January 21, 2021. This facility is being built next to a new development that includes 232 multi-family units for lower-income seniors and a Community Health Partners Healthcare Center, all at Sacco Dr. and Tschache Ln. When a call for contributions to this worthy cause was put out to UUFB this spring, several of our members were able to respond with much-appreciated donations.

#### Activities/Accomplishments

UUFB had 20 meal-providing cooks for the 15 evenings during which we served FP groups that ranged in size from 11 to 24. Many of these volunteers cooked more than once this past year

# Sunday Services Committee

The Covid pandemic had a profound effect on the work of the SSC, as we had to learn how to conduct services online. Our challenges included technological and copyright issues, and our goal of maintaining spirituality, inspiration and a feeling of community in our online services.

#### Mission

We work with the Minister to create services that are inspiring, informative, and stimulating, and which are consistent with Unitarian Universalist principles and the mission of UUFB.

#### Activities

We met each month, or more often if needed, to determine how to meet the ongoing challenges of creating online services. We also participated in task forces on the music coordinator search and technology for live-streaming our services once we return to the sanctuary. We purchased two copyright licenses to increase the number of hymns we could use for our online services. Several of our members watched other UU services so that we could incorporate successful ideas from other online services. Once the Board began to consider the return to in-person services, we communicated regularly with them about needs and issues we had identified about the transition.

#### Accomplishments

- We trained Lay Leaders for Zoom services so that they would feel comfortable with the online format;
- We assisted Christy Huddleston in creating a data base of hymns with copyright permission and we collected recorded music that could be used for the services;
- We regularly provided lay leaders for services with guest speakers or with Rev. Duffy;
- We took advantage of remote participation by speakers and invited speakers from outside our area;
- We arranged for hymns to be recorded and played by Erin Henke;
- We expanded the service "script" to include a wider variety of set pieces of the service, thus assisting lay leaders in their choices for those parts of the service;
- We worked with Christy to revise the service template so that our services could be streamed relatively easily and would run smoothly.

#### Numbers

- 24 services led by Rev. Duffy
- 13 services with UU ministers, other ministers or ministerial interns as guest speakers
- 4 services with outside guest speakers
- 10 services with UUFB members and friends as speakers
